2025-2026 State of Illinois School Health Requirements

Sport Participants-----3RD THRU 8TH GRADE

A current **Physical** or **Sports Physical** within the last 365 days is **required before participation** in sports practice or games is allowed. Physicals are good for 365 days and sports physicals are good for 395 days. Parent must complete and sign health history portion.

Preschool and New Pre-K

- **Certificate of Child Health Examination (Physical) Form** – Due on August 1, 2025 and dated within one year of the first day of school. Parent must complete and sign “health history” portion.

Kindergarten

- **Certificate of Child Health Examination (Physical) Form** – Due on August 1, 2025 and dated within one year of the first day of school. Parent must complete and sign health history portion.
- **Vision Form** – Due by October 1, 2025 and dated within one year of the first day of school.
- **Dental Form** – Due by May 1, 2026 and dated after November 15, 2024.

Second Grade

- **Dental Form** – Due by May 1, 2026 and dated after November 15, 2024.

Sixth Grade

- **Certificate of Child Health Examination (Physical) Form** – Due on August 1, 2025 and dated within one year of the first day of school. Parent must complete and sign health history portion.
- **Dental Form** – Due by May 1, 2026 and dated after November 15, 2024.

Transfer Students

- **Certificate of Child Health Examination (Physical) Form** – Due on or before August 1, 2025 and dated within one year of the first day of school. If transferring in during the school year, Physical is due before the student begins attending school.
- **Vision Form** – Due by October 1, 2025 and dated within one year of the first day of school.
- **Dental Form** – Due by May 1, 2026 and dated after November 15, 2024.

Religious Exemptions

Parents requesting immunization exemption based on religious reasons **MUST** submit the ILLINOIS CERTIFICATE OF RELIGIOUS EXEMPTION TO REQUIRED IMMUNIZATIONS AND/OR EXAMINATIONS FORM. The form must be filled out and signed by the child's healthcare provider as well as parents. Only providers that are listed on the Cert. Of Child Health Exam forms are considered to meet the legal requirements for signing the religious exemptions (**MD, DO, APN, PA**).

ANY STUDENT REQUIRING MEDICATION DURING SCHOOL (asthma, allergy, diabetic, etc): A current **Plan of Action form** and an **Administration of Medications** form is required, to be filled out by the child's healthcare provider as well as a **Medication Request** form filled out by the parent. All medications must be turned in to the office and be **NEW/UNOPENED**. Students are not allowed to keep medications in their backpacks. Medication must remain in the office.

Any questions regarding requirements, OR if an appointment is scheduled after the above deadlines, you must contact the school nurse advisor @ alorentz@standrewslutherschool.org. Failure to have the required health forms submitted to the school office by **October 15, 2025 will result in the student being excluded from school, if health and immunization requirements are not met and submitted to school office by **October 15, 2025**.**
